

Win Your Contract Paid Competition Terms and Conditions

1. Competition details form part of these terms and conditions
2. Entry is open to residents of the UK aged 18 and over, except employees (and their families) of A1 Comms. Proof of identity and age may be required.
3. Use of a false name or address will result in disqualification.
4. Entrants into the Win Your Contract Paid Competition shall be deemed to have accepted these Terms and Conditions.
5. To enter the Win Your Contract Paid Competition you must buy a contract mobile phone (24-month), contract SIM only (12-month or 1-month), or contract tablet (24-month) between 26.02.19 and 26.08.19, and 'Like' the Buymobiles.net or Affordable Mobiles Facebook page.
6. Only one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
7. A1 Comms accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason.
8. The closing date of the Win Your Contract Paid Competition is 23:59 on 26 August 2019. Entries received outside this time period will not be considered.
9. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place on 27 August 2019.
10. The winner will be paid the total cost of their line rental over the 24-month, 12-month or 1-month contract period (the Prize), in the following instalments in equal parts:
 - i. 24-month contract: During month 7, 12, 18 and 24.
 - ii. 12-month contract: During month 7, 8, 10 and 12.
 - iii. 1-month contract: After month 1 (within 30 days).
